THE SANCTUARY RENOVATION COMMITTEE

Many of you are aware that there have been serious discussions going on for several years concerning repairs, upgrades and modifications of our building. These discussions have been driven by a combination of concerns for serious (and possibly dangerous) defects in its infrastructure and a desire to make our building accessible and more useful for the many and varied programs that enrich our congregational life.

Last year our Board engaged the Champaign branch of the design firm RATIO to do a feasibility study of our needs so that we have some idea of possible costs. RATIO's report features three possible scenarios, heavily weighted toward our infrastructure needs and touching more lightly on redesign considerations.

In November of last year, I was contacted by our President Rob Ore and longtime Building Committee chair Art Siegel, and I was asked to form a committee which would have the responsibility of seeing such a renovation project to completion. With the participation of the Board, the following committee was assembled, which we named the Sanctuary Renovation Committee (SRC); its members are: Carol Belber, Laura Bleill, Melanie Dankowicz, Natalie Frankenberg, Sanford Hess, Jessica Kopolow, Susan Schomer (Vice-Chair), Art Siegel, Paul Weichsel (Chair), and Rosalind Weinberg. In considering the issue of design, the Renovation Committee decided that given the limited experience of RATIO with Jewish sacred spaces, it would be useful to reach out to some architects with substantial experience in synagogue design. We contacted the Knowledge Network of the URJ who were very helpful in referring us to available resources. After clearing our ideas with the Board, we have arranged for visits to our building from three architectural firms that do have relevant experiences. Those visits are scheduled to take place later in April and early in May. The total cost of these visits will be well under \$1000.

We are very excited by the prospect of bringing our building into the 21st century in the best sense of the word. We are committed to being transparent with the Board and with the congregation as a whole as much as possible.

The Board will have final approval rights on our recommendations and the congregation will have ample opportunity to comment.

Expect to hear from us on a regular basis.
